

#### **Traditional Model Evolution**

- Libraries buy journal subscriptions individually
- Then journal subscriptions became bundled
- Big Deal
- Ultimate Deal



#### **Transformative Agreements**

- Build off subscriptions
- Gold Open Access
- You get full reading access and some level of OA
- Price is applied on either the read or publish side
- Consortia pricing could be challenging



#### **Transformative Agreements**

- There should be enough money in the entire library system to move to the OA model without paying extra
- IOW-take the money libraries are paying for subscriptions and use it to support the publication of research by their organizations' authors



#### Why are they good for libraries/users?

- Authors don't have to find the money for APCs in their budgets, so it promotes OA publishing
- They create conditions for change in scholarly communication.



#### Why are they challenging for libraries?

- It takes time for author behavior to change/the authors don't know they can publish OA even though there's an agreement in place for free publishing
- Predatory publishing confuses authors and stops them from choosing OA



#### Why are they challenging for libraries?

- Managing transformative agreements is challenging
- Funding models need to change; in higher education subscriptions are paid from the library budget, but open access fees are paid from research budgets.



#### Why are they challenging for libraries/users?

- We are normalizing a system where authors need to pay and where does this leave the authors who are underfunded and underaffiliated
- Puts the burden of the scholarly publishing cost on the large research institutions

#### **Supporting Early Career Researchers**

- 42% of Wmed trainees publish at least one peerreviewed paper
- Increase in trainees engaged in scholarly publishing due to pass/fail scoring of USMLE Step 1 and competitive nature of NRMP match and the fellowship match post residency
- OA fees are not included in tuition



#### **Case Reports**

- Learner's first paper is often a case report
- Case reports usually describe an unusual or novel occurrence
- Case reports are used in education



#### Pilot

- BMJ Case Reports
- Fellowship fee covered by the library
- 50 papers between the pre pilot, pilot, and post pilot period have been published in the journal
- 80% of those papers had trainees as a first author



#### Challenges

- Not easy for the trainee to identify a case suitable for publication
- BMJ Case Reports acceptance rate is 38%
- Library's budget continues to absorb transformative agreement fees
