SWHSL's Future

Barb – Our organization group came together for free document delivery before free share existed and for in-service learning, but things have evolved since then. There are other organizations that can fill this roll. We are the last consortium in the state. Is it worth the effort? Could efforts be combined with WHSLA? Maybe enact changes after MLA meeting?

Karen – There is membership overlap with WHSLA. We have \$3000 in treasury, and we could award more grants to spend it down next year to help with MLA attendance. We really only spend dues on lunch for in-person meetings. Money was acquired from joint meetings with Midwest MLA, but this profit sharing is no longer happening. Money will go away eventually – in about 6 years if we keep giving out a \$500 professional development grant each year.

Kathryn - How much overlap is there with WHSLA and Midwest MLA? Librarians can attend SWHSL without any costs to them (because the institution is the member and pays the dues). What are benefits from all the groups? Can our purpose be adjusted, and can we reenvision what we can be? What do we want the group to be – what are our needs? Is cost a hindrance to some? Would like to know what the other groups do and provide as benefits.

Kathy - Kentucky health science association stopped operating as a formal group and now meets socially with no dues or officers. I's challenging to get people to serve in SWHSL officer roles.

Liz - Is willing to put together a form to gather data on what members want from SWHSL.

Anne – Could a quick comparison chart of 3 groups (SWHSL, WHSLA, and Midwest MLA) be done and shared? How they function, dues, and what they offer.

Karen – If we have money, then we need treasurer. No one is going to come after us if we don't follow our guidelines.

Group agreed to discuss this more at the next meeting.

Could a small group put together info for the next meeting? Liz is member of all three organizations (SWHSL, WHSLA, and Midwest MLA) and volunteered to lead the group. She will ask for volunteers for a small group to work on this. Loren volunteered to help.
